RULES & REGULATIONS

- All riders, regardless of age, are required to wear ASTM/SEI-approved helmets when mounted at events sponsored by 4-H.

- The Jumper Show will be run in accordance with the New England 4-H Horse Show Rules and Guidelines.

- Proof of a negative Coggins test and a rabies vaccination within 12 months is required to exhibit in the Jumper Show; please include copies of the certificates with your registration form.
- Show management reserves the right to combine and/or cancel any classes for lack of entries.
- Horses must be kept at a walk outside of the VSF Horse Arena and designated schooling area.
- Schooling at more than a walk must be done in the designated area only.
- No refunds will be issued for the Jumper Show. All proceeds go to the Rutland County 4-H Foundation for the benefit of 4-H programming for local 4-H youth.
- Competitors are limited to entering no more than 5 jumping classes per day/horse.
- Equitation is judged on the rider's position and handling of the horse. Speed classes are timed, 4 seconds added per knockdown, and refusals are after 3 riders need to retire. Falls require immediate retirement for that class.
- Puisseance is a \$5.00 class (the Rider MUST bring cash), winner takes all cash prize!
- The judge may excuse any rider for any behavior deemed dangerous!
- The judge's decision is final. No exhibitor or spectator may approach the judge without permission and/or accompaniment of show personnel.
- Any patterns will be announced and posted before the class at the announcer's booth.



GENERAL RISK & RELEASE

I hereby enter the **2025 4-H Jumper Show** and acknowledge that I am participating at my own risk.
